In reply to your enquiry on behalf of Jupiters Casino over the receipt of two notifications dated 10 October 1992 and 22 June 1993 for Lot 299 on WD 3639 advising that the site is on the Contaminated Sites Register, please note:

3. the entry of 2. above for GAS will be removed and replaced by UNK (for UNKNOWN) as this site has not been required to be investigated to determine the extent of any contamination arising from the fuel storage on site.
